

Terms and conditions for the COBIS Student Competition (the "Competition")

By entering the Competition, you agree to be bound by these terms and conditions (these "**Terms and Conditions**"). Promotional materials relating to the Competition, including all information on how to enter the Competition, also form part of these Terms and Conditions. In the event of any conflict between any terms referred to in such promotion materials and these Terms and Conditions, these Terms and Conditions take precedence.

1. The promoter of this Competition is Discovery Education Europe Limited, 1 Lyric Square, London W6 0NB ("**Discovery Education**").
2. Participants must be a teacher on behalf of a child between ages 5 and 12 years old who teach at a Council of British International Schools (COBIS) school. Employees and agents of Discovery Education, COBIS or any of their subsidiary or affiliated companies and their immediate families and members of their households, and anyone otherwise connected with operation or fulfilment of the Competition are not eligible to take part. Discovery Education reserves the right to require participants to prove that they are eligible. If the winner is found to be ineligible, Discovery Education reserves the right to award the prize to another participant and to require the return of any prize already awarded.
3. The Competition commences at 00:01 UK time on 8th January 2020 and all entries must be received by 18:30 UK time on the closing date of 26th February 2020].

To enter the Competition you must pre-register with your name, email address, school address and telephone number via the form on the Discovery Education website and complete either the Habitats (for children aged 5-7) or Journeys (for children aged 7-12) challenge. Entries should be submitted by email to discoveryeducationuk@discoveryed.com including their school name, pupil(s) names who created app, email address and telephone number together with the details of your entry (app created as an attachment). Entries submitted by any other means will not be accepted: only those submitted via the official method of entry. Use of script, macro or any automated system to enter the Competition is prohibited and entries made (or which appear to have been made) using any such system may be treated as void. Any illegible, incomplete or fraudulent entries will be rejected. Participants may only win one prize per person, irrespective of the number of entries submitted. At the end of the Competition, participants' entries will not be returned to them

5. The prize to be won per age group is one (1) First Prize of \$250 Amazon voucher (delivered to a school email address), one (1) Second Prize of \$150 Amazon Voucher (delivered to a school email address) and one (1) Third Prize of \$100 Amazon voucher (delivered to a school email address). The winner is responsible for paying all associated costs that are not specifically stated in these Terms and Conditions, including (where applicable) all other incidentals. The winner is also personally responsible for any personal or incidental expenses and any VAT, national and/or local tax liabilities incurred in claiming or using the prize. The prize is as stated and is non-exchangeable and non-transferable. There is no cash or other alternative to the prize in whole or in part. The winner of the Competition will be the person(s) who create the app that most closely follows the competition brief as well is awarded the most points by the panel of judges for meeting the judging criteria. The winner will be selected by 23rd March 2020, by a panel of judges including at least one independent member and the judges' decision is final. In the event of a tie, an independent judge, whose decision shall be final, will choose the most original and creative entry from all complete, eligible, properly submitted entries received before the end of the applicable closing date.
7. Participants agree that any copyright and other intellectual property rights vesting in their entry to the Competition will be owned by Discovery Education and to this effect by entering the Competition participants agree to hereby unconditionally and irrevocably assign to Discovery Education, as legal and beneficial owner and with full title guarantee, by way of present assignment of all present and future rights, all rights, title and interest in all intellectual property rights in or arising out of their entry to the Competition, for their full duration of such rights. Participants also hereby agree to irrevocably and unconditionally waive any and all moral and similar rights vesting in their entry to the Competition and to undertake to execute all such documents as are reasonably required by Discovery Education to perfect the transfer or assignment of all rights, title and interests referred to in these Terms and Conditions to Discovery Education. Participants hereby represent and warrant that they have all rights necessary to grant the rights provided for in this paragraph 7, and that all materials forming part of their entry to the Competition, and any use of such materials by or on behalf of Discovery Education, comply with all applicable laws, rules, and regulations and do not infringe or otherwise violate the intellectual property or other rights of any third party.

Furthermore, participants represent and warrant that they have obtained all rights, licences, and permissions necessary, in writing, from any person who may have helped create and/or be featured in their entry and that their entry to the Competition fully complies with these Terms and Conditions and: (a) is their original work and does not include the work of a third party, or if it does include such work that they have obtained all rights, licences, and permissions necessary, in writing; (b) has not previously been submitted in any competition or other promotion and has not won an award or prize of any kind; (c) does not contain any use of the names, likenesses, photographs, or other identifying elements, in whole or in part, of any person, living, or dead without permission (proof of which must be provided to Discovery Education upon request); (d) does not include trade marks, logos, or copyright protected material which belongs to third parties without permission (including, but not limited to, company names, music, photographs, motion picture or television programme clips or audio tracks, works of art, or images published on or in websites, television, movies, or other media); (e) is not subject to any third party agreements and Discovery Education will not be required to pay or incur any sums to any person or entity as a result of its use (as set out in these Terms and Conditions) or the exploitation of the idea or video or rights therein; (f) does not defame, misrepresent, or contain disparaging remarks or any other content which could adversely affect the name, reputation or goodwill of Discovery Education or any other individuals and/or entities (the determination of which shall remain in the sole discretion of Discovery Education); (g) does not contain pornographic or sexual content, hateful or discriminatory content of any kind (including racism, sexism, etc.), does not contain content which promotes violence or harm to another living creature or any other offensive, obscene or inappropriate content (the determination of which shall remain in the sole discretion of Discovery Education); (h) does not include threats of any kind or anything that may intimidate, harass, or bully anyone, or invade the privacy of any person (the determination of which shall remain in the sole discretion of Discovery Education); (i) does not violate any applicable local state, provincial, national or international law or include any content that would encourage or provide instructions for a criminal offence; (j) does not feature, refer to, or mention any brands competing with Discovery Education; and (k) does not contain any known virus, trojan horse, worm, trapdoor or similar software that may in any way infect or affect any of Discovery Education's hardware or software systems. Discovery Education reserves the right to remove or temporarily suspend from the Competition any content submitted if it suspects any breach of these Terms and Conditions or if it receives any complaint from a third party relating to such content.

8. The winner will be notified no later than 24th March 2020 via the email address provided on entry. The prize will be sent to the winner by email to the email address provided on entry. If any

emails to the winner are returned as undeliverable Discovery Education reserves the right to award the prize to another participant. If the winner has not claimed their prize by the date specified in the notification of winning, Discovery Education reserves the right to award the prize to another participant.

9. In the event that, for reasons beyond Discovery Education's reasonable control and not related to the winner, Discovery Education is unable to award the prize as described in these Terms and Conditions, Discovery Education reserves the right to award a prize of a similar nature and an equivalent value, or at its sole discretion, the cash value of the prize. In the event of a printing or other error resulting in there being more winners than prizes for the Competition, Discovery Education reserves the right at any time to allocate the available prize by the means of a prize draw or to divide the prize or the value of the prize between the winners of the Competition.
10. The provision of the prize does not imply endorsement by Discovery Education of Amazon or any other third parties concerned in any way with the Competition. Any complaints or queries relating to the use of the prize should be directed to Amazon.

You are providing information to Discovery Education and not to Twitter, Facebook or LinkedIn. The information you provide will only be used for the purposes referred to in clause 13 below.
13. Discovery Education will collect and process participants' personal information and it will be shared with COBIS to the extent necessary in order to conduct the Competition including for the prize to be delivered to the winner. If participants do not provide any of the mandatory information requested when entering and taking part in the Competition, they may not take part in the Competition. Participants' names and other personal details from their entry to the Competition will be collected and stored by Discovery Education and held in accordance with the applicable [privacy policy](#) in place from time to time.

Discovery Education reserves the right to modify, cancel, terminate or suspend the Competition in whole or in part, at its sole discretion, if it believes the Competition is not capable of being conducted as specified within these Terms and Conditions or in the event of a virus, a computer bug or unauthorized human intervention or any other cause that is beyond the reasonable control of Discovery Education that could corrupt or affect the administration, security, impartiality or normal course of the Competition. Neither Discovery Education nor any of its subsidiary or affiliated companies are responsible for any condition, circumstances, losses, failures or delays caused by events beyond its or their control such as (but not limited to) the acts or defaults of any supplier selected by Discovery Education to provide the prize or otherwise that may cause the Competition to be disrupted or corrupted, or that may lead to loss or damage of the prize in transit to the winner.

Save where it has been negligent, Discovery Education will not be responsible for any damage, loss or injury resulting from participants' entry into the Competition or their acceptance and/or use of the prize, or for technical, hardware or software failures, lost, faulty or unavailable network connections or difficulties of any kind that may limit or prohibit their ability to participate in the Competition. Furthermore, where such actions have significantly impaired the Competition, Discovery Education may, at its sole discretion, add further stages to the Competition as it deems reasonably necessary in order to resolve any problems arising as a result of such actions.
17. All Discovery Education's decisions in relation to the Competition are final and Discovery Education will not enter into any correspondence with participants.
18. These Terms and Conditions are governed by English law. The courts of England and Wales shall have exclusive jurisdiction to hear any dispute or claim arising in association with the Competition or these Terms and Conditions.
